## 2017-2018 Carrie Souter Memorial Award

Created in memory of fashion designer Carrie Souter. This award will provide financial assistance and recognition to an undergraduate student in the School of Fashion who excels in illustration.

**Number:** 1 award is available to a second, third, or fourth year student enrolled in FFC 404, FFD 414 or FSN 700.

**Value:** up to \$2000

### Eligibility/Criteria:

- Must be a Canadian Citizen; a Permanent Resident or a Protected Person;
- Must be an Ontario resident;
- Must demonstrate financial need as determined by Ryerson University through completion of a detailed budget submission in accordance with OTSS guidelines;
- Must be a second, third, or fourth year full-time student enrolled in FFC 404, FFD 414 or FSN 700;
- Must be in clear academic standing with a minimum CGPA of 3.00;
- Demonstrate excellence in the design created and executed in their apparel design course and illustrated in their visual communication course. The illustration submission may either be new, original work or a completed project from FFC 404, FFD 414 or FSN 700.

**Decision:** The winner will be notified via their Ryerson email.

**Presentation:** School of Fashion annual Awards Ceremony in November 2018.

**Application:** Submit this cover page, an illustration, the OTSS student budget form and the FIPPA agreement.

**Deadline:** Friday, September 21, 2018 by 4:00pm
