Eligibility/Criteria:

- Must be a Canadian Citizen; a Permanent Resident or a Protected Person;
- Must be an Ontario resident;
- Must demonstrate financial need as determined by Ryerson University through completion of a detailed budget submission in accordance with OTSS guidelines;
- Must be a second, third, or fourth year full-time student enrolled in the Fashion Communication or Fashion Design program in the School of Fashion;
- Must be in clear academic standing with a minimum CGPA of 3.00;
- Must submit a CV/Resume;
- Must demonstrate in a written statement (500 words) describing their extraordinary contribution to the School of Fashion, Ryerson University and the community, **OR** submit a letter of support from a faculty member detailing this contribution.

Decision: The winner will be notified via their Ryerson email.

Presentation: School of Fashion annual Awards Ceremony in November 2018.

Application: Submit this cover page, a CV/Resume, a written statement or a faculty letter of support, the OTSS student budget form and the FIPPA agreement.
